

San Diego Food + Wine Festival Sweepstakes ("Sweepstakes")

Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** Sweepstakes is open only to those who sign up at the online Sweepstakes page and who are age 21 or older as of the date of entry. The Sweepstakes is only open to legal residents of the fifty (50) United States and the District of Columbia (excluding Alaska) and is void where prohibited by law. Employees of Fast Forward Events, LLC, the San Diego Food + Wine Festival, Southwest Airlines Co., and their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. 3. **Sweepstakes Period:** Entries will be accepted online starting on August 17, 2026 at 8:00AM PST and ending August 30, 2026 at 11:59 PM PST. San Diego Food + Wine Festival's computer is the official timekeeping device for this Sweepstakes.
4. **How to Enter:** The Sweepstakes must be entered by visiting <https://www.sandiegowineclassic.com/southwest-sweepstakes/> and submitting an entry using the online form provided on the Sweepstakes site. The entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the Official Rules or specifications may be disqualified at the sole discretion of San Diego Food + Wine Festival. You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of San Diego Food + Wine Festival.

 - Two (2) General Admission tickets to the Grand Tasting Presented by Southwest Airlines® on Saturday, November 7, 2025
 - Two (2) General Admission tickets to the Grand Fiesta Presented by Southwest Airlines® on Sunday, November 8, 2025
 - Round trip air travel for winner and one (1) guest on Southwest Airlines® (subject to Air Travel Restrictions set forth below).

San Diego Food + Wine Festival's first priority is the safety and health of attendees, sponsors, entertainers, production crew, volunteers, and staff. Working closely with the venue and the Health Department, the San Diego Food + Wine Festival is putting in place what the necessary requirements based on recommendations from the proper authorities. As such, all attendees will be required to abide by the COVID-19 Protocol, which will evolve as the event approaches and may include any or all of the

following measures: liability waivers, face coverings, social distancing, non-invasive temperature checks, testing, or proof of vaccination. San Diego Food + Wine Festival reserves the right to modify and add requirements at its sole discretion. The Terms & Conditions page will be updated with those protocols as the event approaches. Cooperation with published health and safety protocols on-site will be required to enter and participate in the Festival.
